The Romoland School District is seeking applicants for a provisional appointment to the Romoland School District Board of Education Trustee Area 3. This is a short-term vacancy ending December 2024 as a result of a failure to elect for trustee area 3 within the district.

Board Responsibilities

The Romoland School District Board of Education consists of five members, each elected from a different area of the district. Board members are elected for four-year terms and must be registered voters in their respective areas. This provisional appointment is for a short-term ending in December 2024.

A president and clerk are elected by the Board at its annual organizational meeting in December. A quorum of three members is required to conduct official business and to execute action. Regular board meetings are scheduled monthly on the second Tuesday of every month (excluding July).

The Board also:

- Approves regulations and curriculum for the schools and educational programs.
- Adopts policies governing the Romoland School District.
- Approves the annual budget of the Romoland School District
- Receives the annual audit.
- Approves the purchase or lease of property.
- Advocates on behalf of education on the local, county, state, and national level.
- Informs local communities about the programs and achievements of the Romoland School District.

In order to qualify to serve on the Romoland School District, an applicant must be:

- At least 18 years of age
- A citizen of the State of California
- A resident of the Romoland School District, Trustee Area 3
